DATA COMPLIANCE TERMS.

I understand that the information given above will be stored on paper and a password protected PC by the Membership Secretary. I understand that Names, Email addresses, and telephone contact numbers above are entered on to the Club Gmail Account, and officers of the club with legitimate interest have access to these. I understand that other officers of the club may from time to time require the information above and this will be provided on an as necessary basis via direct personal Email only, and not on a permanent basis. I understand the details will be used only for the purposes of administering the club and any associated rowing activities. I agree that names and dates of birth can be provided to WEARA or British Rowing for racing and administrative purposes by email, but understand that it will not otherwise be shared with anyone else outside the club without my explicit consent. The information will be deleted after 2 years non- attendance and I have ceased paying my child's annual subscription, or it will be deleted at my request. I have a right to access to my child's stored data, and request any information regarding storage and access from the Membership secretary at any time. If I think there is a problem with the way my child's data is handled I will contact the Membership Secretary, and I have a right to complain to the Information Commissioner's Office.

Club Coaches and Outing Leaders may form lists of members appropriate to their training groups on social media such as Facebook, Messenger or Whatsapp, in order to communicate information regarding their training. Your child may be invited to join, and they will only be added with your consent. You can remove your child from a group at any time electronically or via the club officer in charge of the list.
